

CHAIN OF COMMUNICATION

This **Chain of Communication** is designed to assist parents/guardians with identifying the appropriate sequence to use when seeking an answer to a question or resolution to a concern. We understand that when contacting the district, it may be frustrating to be redirected to someone else; however, many questions and concerns are able to be answered or resolved by the teacher or appropriate staff with oversight of your child's program. Therefore, all parents/guardians are encouraged to start all inquiries with your child's teacher(s). If your question or concern remains unresolved by your child's teacher or staff member with oversight of your child's program, this **Chain of Communication** identifies the appropriate channel through which communications can be elevated.
